RE: Important Information Regarding GCSE Results Day and Post-Results Services

As we approach the end of the academic year, I am writing to outline the key arrangements for GCSE Results Day on **Thursday, 20th August 2026**, and to explain how results are managed and processed at Carisbrooke College.

1. Collection of Results

Results will be available for collection in person from the **canteen** between **08:00 AM** and **11:00 AM** on **Thursday, 20th August 2026**.

- **Collection in Person:** Students are encouraged to collect their results in person. Staff and the Examinations Team will be on hand to celebrate achievements and provide guidance on next steps.
- **Collection by a Nominated Representative:** If a student is unable to attend, someone else may collect the results on their behalf. To enable this, the student must provide written permission, or complete the Nominated Representative Google Form attached to this email, in advance to **charlotte.turner@carisbrooke.iow.sch.uk**, naming the representative. The representative must bring photo ID on the day.
- **Uncollected Results:** Any results not collected by **12:00 PM (noon)** will be sent via first-class post to the home address we have on record.

2. Post-Results Services (Reviews of Marking & Scripts)

When results are issued, exam boards offer a range of post-results services. If a student feels a grade does not reflect their performance, or if a specific grade boundary is needed for progression, the following options are available:

- **Access to Scripts (ATS):** Candidates can request a copy of their marked exam paper to review with subject teachers. Here is how - form - deadline 26 August at 3pm - to allow school to then process the requests.
- **Review of Results (RoR):** Candidates can request a review of marking by the exam board.

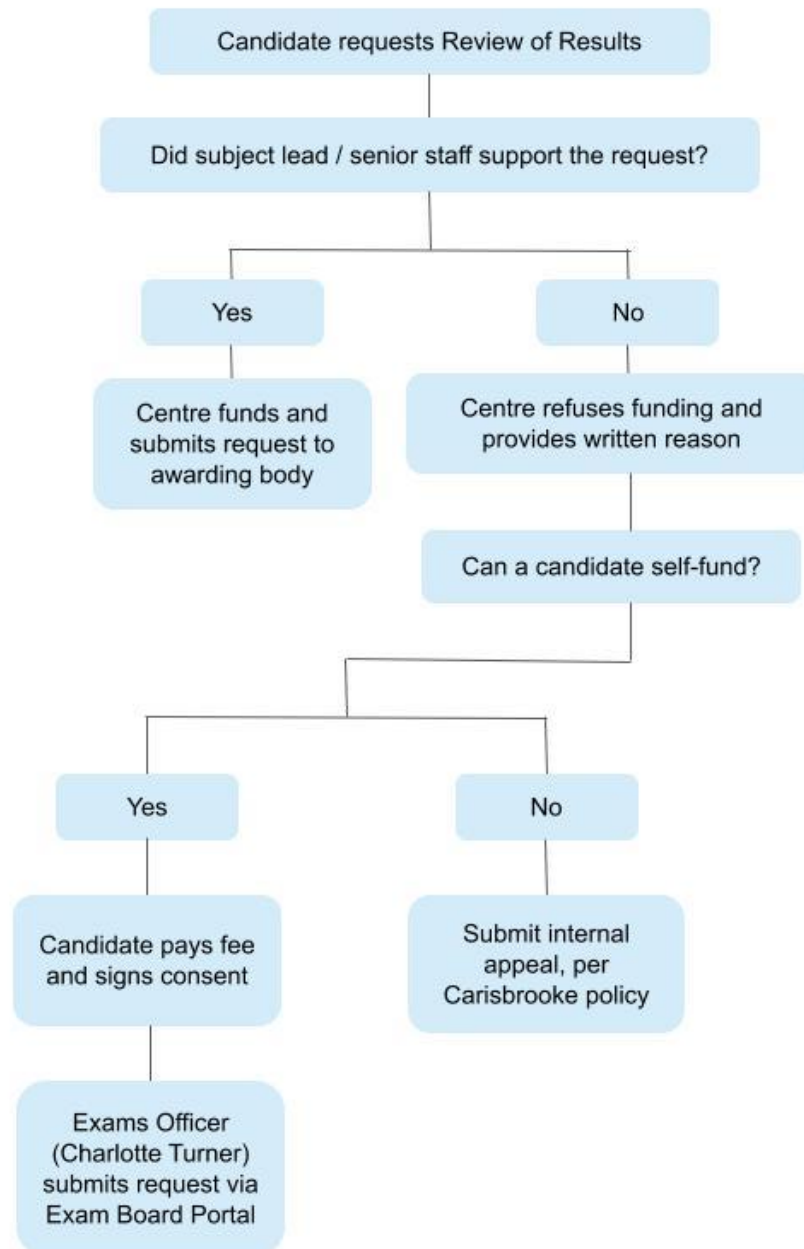
Important Note on Grade Changes: Please be aware that when a review of marking is submitted, **marks and grades can go down as well as up, or stay the same**. Written consent directly from the candidate is required before any review can be requested.
